### **Objectives of the POCSO Committee**

- To ensure all staff members are trained to identify, prevent, and appropriately report concerns related to child safety.
- To establish a transparent mechanism for reporting and addressing complaints related to child abuse.

### **Key Responsibilities**

 Conducting regular awareness programs, workshops, and special assemblies to sensitize learners about safety and responsible behavior.

- Organizing orientation and training sessions for teachers, administrative staff, and support staff to help them recognize early signs of abuse and to follow proper reporting protocols.
- Ensuring the placement and periodic monitoring of **Complaint Boxes** in accessible areas of the school to encourage reporting in a confidential manner.
- Reviewing and addressing any complaints received and taking appropriate action in accordance with legal guidelines.
- Maintaining detailed documentation and ensuring compliance with child-protection norms.

### **Awareness and Capacity-Building Initiatives**

Throughout the academic year, the Committee undertakes multiple initiatives, including:

- Showing age-appropriate educational videos on personal safety and protection.
- Conducting self-defense training sessions to equip learners—especially girls—with essential skills to protect themselves.
- Encouraging **student participation** in discussions, assemblies, and awareness drives to foster confidence and open communication.
- Displaying child-safety guidelines and emergency contact information in classrooms and common areas.
